## Finmeccanica: Peruvian Ministry of Defense selects the Alenia Aermacchi C-27J Spartan tactical airlifter

Alenia Aermacchi, a Finmeccanica Company, has been selected to supply the Peruvian Ministry of Defense with 2 C-27J Spartan tactical airlifters. The contract, to be signed as soon as the administrative procedures are completed, has a value of around 100 million euro inclusive of a substantial logistic support package for the two aircraft.

The C-27J - known as the only true military transport aircraft of its category available on the market - has been selected by the Fuerza Aerea del Perù due to its proven operational flexibility at competitive costs; the best performances in its class in all operational and environmental conditions and because it is the only aircraft in its class interoperable with heavier airlifters already in service in Peru.

"The choice by the Peruvian MoD – said the Company- is a confirmation that, when an air force has a stringent airlift requirement in terms of performances and capabilities, the Spartan is the only solution able to guarantee an excellent value for money. The C-27J is a clear example of the capabilities of the Italian aeronautical industry, but this success is also the result of the intense relationship between Italy and Peru in the defense field since 2002 and which is constantly renewed through the years".

The selection process held by the Peruvian MoD was meticulous and lasted almost 3 years. The requirement asked for an aircraft able to operate in total safety in the most difficult conditions as those found over the Andes. During the operational evaluation run in Peru, the C-27J demonstrated its capability to perform a variety of missions including transport of civilians, troops, materials and medicines, logistical re-supply, MEDEVAC, airdrop operations, search and rescue (SAR), humanitarian assistance and operations in support of homeland security and Civil Protection, with the capability to operate on a large number of airfields where its competitor is unable to land.

Finmeccanica is Italy's main industrial group, leader in the high technology field, and ranks among the top ten groups at world level in the Aerospace, Defence and Security sectors. Listed on the Milan Stock Exchange (FNC IM; SIFI.MI), with revenues of approximately 17 billion Euro, over 68,000 employees, 150 operating and commercial locations and 345 production facilities in 50 different countries world-wide, Finmeccanica is an international and multicultural group with an important presence in its four domestic markets: Italy, United Kingdom, the United States and Poland. Finmeccanica's success is based on its technological excellence, which springs from conspicuous investments in Research & Development (amounting to 12% of the revenues), and the constant efforts it makes to develop and integrate the skills, know-how and values of its operating companies. Finmeccanica is active in the following sectors: Helicopters (AgustaWestland), Defence Electronics and Security (Selex ES, DRS) and Aeronautics (Alenia Aermacchi) – which represent its core business – and it is also well positioned in the sectors of Space (Telespazio, Thales Alenia Space), Defence Systems (Oto Melara, WASS, MBDA), Energy (Ansaldo Energia) and Transportation (Ansaldo STS, AnsaldoBreda, BredaMenarinibus).

The Spartan has already been ordered by the air forces of: Italy, Greece, Bulgaria, Lithuania, Romania, Morocco, Mexico, United States, Australia and by an undisclosed African country for a total of 74 aircraft. The aircraft has also been selected by Slovakia and the contract is under negotiation.
