**NOTICE PURSUANT TO ART. 84 OF ISSUER'S REGULATION**  
(Consob Resolution n. 11971/1999 and subsequent amendments)

Shareholders are hereby notified that has been filed with the Rome Companies Register, as provided for by art. 2501 *ter*, par. 3 of the Italian Civil Code, the Merger by incorporation Plan of UTM Systems & Services S.r.l. into Leonardo – Società per azioni (hereinafter also the “Company” or “Leonardo”), approved by the Company’s Board of Directors on July 30, 2024.
